Dr Rajpal is a fully registered Specialist Oral Surgeon. He has completed close

to 10 years of training from both the University of Otago, NZ and the University of Sydney, Australia. Graduating with a Clinical Doctorate of Oral Surgery has allowed him to become a highly trained specialist. Dr Rajpal practices the full scope of oral surgery including management of pathology such as cysts and tumours of the jaws, surgical removal of teeth including wisdom teeth, placement of dental implants, both bone and soft tissue grafting procedures, as well as management of jaw joint disorders and facial pain. He has previously been a consultant Oral Surgeon in public hospitals within Sydney and now calls Auckland home. Dr Rajpal was a Clinical Lecturer and Examiner in Oral Surgery at bot the undergraduate as well as postgraduate levels with the University of Sydney. He is also involved with clinical research having recently completed his research on the Epidemiology of Facial Fractures in NSW.
